General Information & Conditions of Entry

1. Entry Form must be completed honestly, accurately, legibly and **SIGNED BY EACH TEAM MEMBER**.
2. Use only **one** entry form per team.
3. **AGE IS DETERMINED BY THE AGE A COMPETITOR WILL BE ON 12th SEPTEMBER 2008**
4. If under 18 years of age, entry forms must be signed by **both Parents or Guardians**.
5. WKF (World Karate Federation) rules will be applied to this tournament and modified at the discretion of the organisers. Some events may be officiated using the Judge Mirror System.
6. Competitors are responsible for their own Public Liability & Professional Indemnity Insurance including Participation (Member to Member) & Sports Injury / Accident cover.
7. The organisers reserve the right to combine or cancel divisions where there are insufficient entries.
8. **Only NCAS qualified coaches will be permitted in the competition area and all coaches must wear club tracksuit. Coaches Registration Form must be completed and returned to the AKF Inc. no later than 3rd March 2008.**
9. **It is an AKF Inc. condition of entry that any competing athlete or attending coach is NOT under any current or existing performance enhancing drug sanctions from WADA or the relative agency/s of the country of origin of the competing athlete or attending coach.**

KUMITE

1. Senior male divisions will be 3 minutes. All other divisions will be 2 minutes.

COMPULSORY SAFETY EQUIPMENT

- a. Groin Guards (Males) and Mouthguards and WKF approved red and blue Mitts – **All competitors**.
- b. WKF approved red and blue combined Shin/Instep Protectors – **All competitors** (Children, Cadets, Juniors & Seniors).
- c. Chest protection (Females – Cadets, Juniors & Seniors)

KATA

1. Children / Cadet / Junior / Senior: Must have minimum two Kata. Free choice Kata for all teams. May repeat Kata but not in consecutive rounds.
